4.1	The Proposed Hire Report / Incentive Plans - \$3,000 and Under / Incentive Plans	The Proposed Hire Report is a weekly report of all active job postings that were opened in the prior week, to recruit and hire new SLCo employees. The Incentive Plan Report is a list of all recently approved incentive plans that total \$3,000 or less. The Weekly Reclassification Report is a report of all job reclassifications that were completed in the prior week.
4.2	Consideration of an Incentive Plan over \$3,000	This is an incentive plan that is over the \$3,000 threshold and will need Council approval.
4.3	Establishment of Process for Memorials in the form of Proclamations for the Salt Lake County Council and Related Legislative Intent	This legislative intent aims to formalize a process for the issuance of memorials in the form of proclamations. The intent is to include the signatures of all Salt Lake County Council members on noncontroversial proclamations. Such documents, which commend individuals or groups for noteworthy activities and achievements or honor cultural events and occasions, will automatically bear the endorsement of the entire Council unless a specific council member explicitly opts out.

6.1	Consideration of Final Adoption of an Ordinance of the Salt Lake County Council Dissolving the Magna West Main Street Neighborhood Development Project Area	The Council will consider an ordinance to dissolve the Magna West Main Street tax increment financing project area. Previously, the Governing Board of the Redevelopment Agency of Salt Lake County adopted a resolution to dissolve the Magna West Main Street project area. This ordinance before the Council now completes the process required for project area dissolution, as required by Utah Code 17C-1-702(2)(b).

7.1	Consideration of Acceptance of the ShelterKids' 2023 Angel Tree Campaign In-Kind Donation valued at \$207,437.57 to Support Salt Lake County Youth Services' Programs	Request for consideration of acceptance of an in-kind donation valued at \$207,437.57 from the ShelterKids' 2023 Angel Tree Campaign to support Salt Lake County Youth Services' Programs ShelterKids is one of Salt Lake County Youth Services' nonprofit partners and has donated items to Youth Services as part of the Angel Tree program. The annual ShelterKids' Angel Tree runs for 6 weeks leading up to the holidays and brings in donations to support Youth Services' programs throughout the year. The Angel Trees are in several of the Salt Lake County Library branches and the Salt Lake County Government Nort Building.  Donations include new clothing, games, hygiene products, toys, art supplies, snacks, and more.
7.2	Consideration of Approval of Salt Lake County Constable Jeremey T. Reitz's Appointment of Tomas Pena as a Deputy Constable	Salt Lake County Constable Jeremy T. Reitz has submitted an application and supporting information necessary to appoint Tomas Pena to serve as a deputy constable under their authority pursuant to Salt Lake County Ordinance § 2.50.090. If approved by the Council, Tomas Pena would serve as a deputy constable under Constable Reitz's authority for a term of six years, or until the termination of Constable Reitz's term, which is currently set to expire on June 30, 2025.
