The owner of Lot 17 and the property surrounding the County Property. would like to redevelop its property. In order to facilitate this process and preserve the unique history of this area, the Lot 17 Owner would like to relocate certain historical elements on the A Resolution of the Salt Lake County Property and Lot 17 from their current locations to a location **County Council Authorizing** along North Union Ave that is closer to the historic location of Fort Execution of an Interlocal Union and which will provide better public access to and awareness of Cooperation Agreement with the historical elements. The County and Midvale City believe that this Midvale City for the Transfer of relocation would benefit the public by improving access to and Certain Real Property increasing awareness of the historical elements and preserving their historical significance to the City and the County. The City is willing to acquire the County Property, facilitate its disposal in accordance with the City's statutory and constitutional obligations, and oversee the relocation of the historic elements to the New Location. It has been determined that the best interests of the County and the general public will be served by transferring the County Property to the City as proposed in the attached Interlocal Cooperation Agreement.
