The Regional FIRST Robotics Competitions is a High School Engineering STEM program that advances winners to the National Competition in Houston at the end of April. The Competition culminates a season that begins in September in the schools and communities as an after-school program that occurs before graduation. This request includes the rental of bleachers with seating for 2000. Salt Lake County becomes a Major Sponsor and allows the Utah Teams advancement in the STEM fields. The community impacts are significant with proven results from the past decade. We anticipate the Competition to move to the South Town Exposition Center in 2025 and be able to reduce costs by 29% by more efficient use of space
